## URGENT: Release Tashi Wangchuk



33-year old Tibetan shopkeeper and language rights advocate Tashi Wangchuk bravely pressed Chinese authorities for rightful Tibetan language education. This simple, legal action earned him five years in prison with a release date of January 2021. Call for his release now.

Tashi Wangchuk was detained on 27 January 2016 and tried on 4 January 2018 on trumped up charges of 'inciting separatism', after he shed light on China's failure to protect the basic human right to education.

On 22 May 2018, China gave Tashi Wangchuk a five year prison sentence, despite the fact that he has committed no crime under international law nor the Chinese constitution. China's 'evidence' against Tashi was a short video documentary by The New York Times about Tashi's campaign for Tibetan language education in schools.

Tashi's lawyer has indicated he plans to appeal the wrongful conviction and five year sentence. Adding your signature could be the tipping point we need to bring him freedom.
